1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 30-A MRSA §4312, sub-§3, ¶J**, as amended by PL 2015, c. 349, §1, is
3 further amended to read:

4 J. To promote and protect the availability of outdoor recreation opportunities for all
5 Maine citizens, including access to surface waters; ~~and~~

6 **Sec. 2. 30-A MRSA §4312, sub-§3, ¶K**, as enacted by PL 2015, c. 349, §2, is
7 amended to read:

8 K. To encourage municipalities to develop policies that assess community needs and
9 environmental effects of municipal regulations, lessen the effect of excessive parking
10 requirements for buildings in downtowns and on main streets and provide for
11 alternative approaches for compliance relating to the reuse of upper floors of
12 buildings in downtowns and on main streets-; and

13 **Sec. 3. 30-A MRSA §4312, sub-§3, ¶L** is enacted to read:

14 L. To plan for the effects of the rise in sea level on buildings, transportation
15 infrastructure, sewage treatment facilities and other relevant state, regional, municipal
16 or privately held infrastructure, property or resources.

17 **Sec. 4. 30-A MRSA §4326, first ¶**, as amended by PL 2001, c. 578, §15, is
18 further amended to read:

19 A growth management program must include at least a comprehensive plan, as
20 described in subsections 1 to ~~4~~ 4-A, and an implementation program as described in
21 subsection 5.

22 **Sec. 5. 30-A MRSA §4326, sub-§4-A** is enacted to read:

23 **4-A. Addressing sea level rise.** A coastal municipality or multimunicipal region
24 that includes a coastal municipality may include in its comprehensive plan projections
25 regarding changes in sea level and potential effects of the rise in sea level on buildings,
26 transportation infrastructure, sewage treatment facilities and other relevant municipal,
27 multimunicipal or privately held infrastructure or property and may develop a
28 coordinated plan for addressing the effects of the rise in sea level. For the purposes of this
29 subsection, "coastal municipality" means a municipality or township in the coastal zone
30 as identified by a coastal program administered by the Department of Marine Resources.

31 **Sec. 6. 38 MRSA §1801, sub-§§8 and 9**, as enacted by PL 1985, c. 794, Pt. A,
32 §11, are amended to read:

33 **8. Water quality.** Restore and maintain the quality of our fresh, marine and
34 estuarine waters to allow for the broadest possible diversity of public and private uses;

COMMITTEE AMENDMENT “ ” to H.P. 407, L.D. 563, Bill, “An Act To Help Municipalities Prepare for Sea Level Rise”

Amend the bill by striking out all of sections 5 to 7 and inserting the following:

'Sec. 5. 30-A MRSA §4326, sub-§4-A is enacted to read:

4-A. Addressing sea level rise. A municipality or multimunicipal region that is in the coastal area may include in its comprehensive plan projections regarding changes in sea level and potential effects of the rise in sea level on buildings, transportation infrastructure, sewage treatment facilities and other relevant municipal, multimunicipal or privately held infrastructure or property and may develop a coordinated plan for addressing the effects of the rise in sea level. For the purposes of this subsection, "coastal area" has the same meaning as in Title 38, section 1802, subsection 1.'

Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

SUMMARY

This amendment clarifies that a municipality or multimunicipal region that is in the "coastal area" as that term is defined in the Maine Revised Statutes, Title 38, section 1802, subsection 1 is subject to the bill. The amendment also strikes from the bill a requirement that state, local and certain federal agencies responsible for regulating, planning, developing or managing coastal resources conduct their activities affecting the coastal area consistent with the policy of encouraging the assessment of and planning for the effects of the rise in sea level.
